# MINUTES.

## SATURDAY'S PROCEEDINGS.

The 35th annual session of the Yellow Creek Baptist Association convened with the Shiloh Baptist Church on Saturday, October 5th, 1895, at 11 o'clock a. m.

The introductory sermon was preached by Eld. S. M. Waldrop.

After intermission of one hour, during which a most elegant repast was served by the good people of Bell and vicinity, the delegates re-assembled in the church house by singing. The former moderator being absent, on motion Elder A. W. Green was elected moderator pro-tem; after singing, prayer by Elder H. W. Lantrip, and the Association was called to order. The letters from the churches were called for, and read by brethren H. W. Lantrip and F. G. Armstrong, and names of delegates enrolled. (See Statistical Table.)

The Association proceeded to the election of officers for the present year, which resulted as follows:

(Brethren F. G. Armstrong and J. R. Guin, acting as tellers.) Elder A. W. Green, Moderator; E. B. Guin, Clerk, and T. M. Woods, Corresponding Secretary.

The Moderator called for petitionary letters, whereupon the following were received: Meadow Branch and Nall's Chapel churches, through their delegates, and the right hand of fellowship extended to them by the Moderator.

On motion, Vernon church was reinstated and delegates seated.

## MONDAY'S PROCEEDINGS.

The Association met pursuant to adjournment; after singing, prayer by the Moderator.

The Association announced in order for business.

On Ministerial Education—Read, and after some interesting talks by Elder R. B. Hughey and others, on motion the report was amended by striking out the words "two and a half cents per member," which was adopted as amended. (See appendix E.)

Collection was taken for Ministerial Education, which amounted to \$23.05.

Adjourned for dinner.

## EVENING SESSION.

The Association met pursuant to adjournment, prayer by Elder J. F. Willis.

The Moderator announced the body in order for business.

On Sunday Schools, which was read, and after several short, touching and appropriate talks by the brethren. Bro. John D. McCluskey, offered the following resolution:

Whereas, Ministerial Education and Scriptural knowledge generally, is now, and has been heretofore, at a very low ebb, and that there is a great lethargy in the churches of this Association in regard to Sunday School interest; therefore be it

*Resolved*, That this Association elect two good and efficient lecturers, one of whom shall be in one district and the other to be in the other district. To lecture the churches in their respective districts and organize Sunday Schools at each church; be it further

*Resolved*, That the pastors of the different churches be made ex-officio member, of said lecturing committee, and are hereby directed to act with them, and to give such lecturers all the aid in their power in perfecting such Sunday School work. Be it further

*Resolved*, That such lecturers shall make a full and complete report in writing back to this body at its next session.

After able speeches by J. D. McCluskey, J. R. Guin and others was adopted. Also report adopted. (See appendix F.)

Brethren J. D. McCluskey and E. B. Guin were elected as lecturers, each one for his own district.

On Temperance—Report read and after some strong and able talks was adopted. (See appendix G.)

On Missions—Report read and after several good talks was adopted. (See appendix H.)

On Literature—Report read and after discussion was tabled.

On Aged and Infirm Ministers—Report read and after much discussion was adopted. (See appendix I.)

On Digest of Church Letters—Report read and adopted. (See Appendix J.)

On motion, retain same Ex. Missionary Board another year. Report of District Meetings. (See appendix K.)

Treasurer's Report. (See appendix L.)

Called for report of Missionaries, which was read and adopted. (See appendix M.)

Called for report of Ex. Missionary Board. (See appendix N.)

On motion Executive Missionary Board is hereby instructed to pay the funds collected over to the missionaries equally.

On motion,

*Resolved*, That we endorse and approve the application of our Bro. Jasper E. Green, and recommend him to the favorable consideration of the State Board of Missions for such aid as they may extend. We pledge ourselves as individuals and as churches to exert every effort in our power to raise funds for the cause of Ministerial Education; all funds to be paid to the treasurer of the board toward the support of Bro. Jasper E. Green, as said beneficiary.

*Resolved*, That the clerk be authorized to have 500 copies of minutes printed, including the Constitution, Abstract of Faith and Rules of Decorum; retain \$8 00 for his services, reserve 50 copies of minutes for correspondence.

On motion, retain same treasurer for next year.

On motion, called the roll and marked out absentees.

On motion, Bro. J. F. Peeler, was excused.

Corresponding letters were read and adopted.

Package of "The Alabama Baptist" received and distributed, and short speeches made by the Moderator and Bro. H. W. Lantrip, who recommended the brethren to subscribe for the paper.

Bro. J. D. McCluskey offered the following:

*Resolved*, That the thanks of this body are due and are hereby tendered to the brethren and sisters of Shiloh church and the citizens of this vicinity for their kindness and hospitality extended to us during our stay among them.

On motion, the Association adjourned to meet with Spring Hill Baptist Church, Fayette County, Ala., 12 miles northwest of Fayette, Ala., at 11 o'clock a. m. on Saturday before the 1st Sunday in October, A. D. 1896.

Prayer by Bro. H. W. Lantrip, then sang hymn "God be with you till we meet again," and took the parting hand.

## REPORT ON MINISTERIAL EDUCATION.

We, your committee on Ministerial Education, beg leave to submit as part of our report the report of the committee on Ministerial Education of the last Association.

In this advanced age of the world and with the lights we have before us, no argument is needed to sustain the work of Ministerial Education, as long as preaching remains to be teaching, and so sure as men can teach only that which they have learned, so long will the education of ministers be necessary.



The important question is, What part will we take in this matter? A great work is being done by the Baptists in Alabama along this line. Have we any part in this work? Now, brethren, in order that we may do something in this work, we recommend, first, that each church of this Association be requested to try to raise all in their power for the purpose of Ministerial Education; second, we recommend that the Committee on Missions be, and is hereby requested to do what it can to collect said amount from each church by the 1st of February, 1896, paying the same to the order of the State Mission Board. We find that there has been \$5.60 raised and \$5.00 paid out, leaving a balance of 60 cents on hand. We also find that there should have been about \$28 00 raised for said purposes. We must say that there seems to have been neglect on the part of those whose duty it was to have raised said funds, and in order to be sure of raising the funds in the future we hereby recommend that the clerk of each church be empowered to raise all he can and turn it over to the Committee on Missions.

## CONSTITUTION.

ARTICLE 1. The Association shall be composed of members chosen by different churches in our Union, who, on producing letters certifying their appointment, shall take their seats.

ART. 2. This Association shall be known by the name of the Yellow Creek Baptist Association, and shall have the privilege of carrying out missionary operations according to the Scriptural plan of conducting missions. Yet, so that members are left free, and that giving or withholding shall not be a bar to fellowship.

ART. 3. This Association shall usurp no authority over the churches in our Union, nor infringe any of their internal rights, but shall merely be considered an advisory council in all matters relative to their eternal concerns.

ART. 4. The principal business of this Association will be to endeavor to promote harmony in the churches composing it, and the Association or deliberative bodies with which it may correspond, and in general, to dispense such Gospel truths as may tend to root out error and promote the declarative glory of God.

ART. 5. The delegates shall produce to the Association, letters from their respective churches, certifying their appointment as delegates, and also, containing a statistical table of their respective churches.

ART. 6. Each church is entitled to three delegates from the laity, with the privilege of sending her ministers.

ART. 7. New churches may be admitted into our union by delegates bearing petitionary letters; if upon due examination they be found orderly and orthodox, the Moderator shall manifest their admission by giving their delegates the right hand in token of fellowship.

ART. 8. The Association, when convened, shall be governed by a regular and proper decorum.

ART. 9. At every session of the Association, a Moderator and Clerk shall be chosen by and from the delegates present, who shall serve until successors are elected.

ART. 10. This Association admits the right of any one of the churches composing it, to withdraw at any time from the body without assigning any reason for so doing, but she claims the power to withdraw from and disown any church which departs from the principles of this compact, by becoming either heterodox in faith or disorderly in practice.

ART. 11. Every query sent by a particular church must be enclosed in a letter.

ART. 12. This Association may have a fund to be raised by the voluntary contributions of the churches or individuals,

which funds shall be placed in the hands of the treasurer, and paid out by order of the Moderator at the discretion of the Association.

ART. 13. The Association shall elect a Treasurer annually, whose duty it shall be to take charge of the Associational fund, and pay out the same agreeable to order, and make at every session a fair and full report of all monies thus received—the expenditures and the surplus on hand, if there be any, which report shall be spread upon the minutes.

ART. 14. The Association shall not adjourn any session until it shall have finished all business on hand, except in extraordinary cases.

ART. 15. It shall be the duty of the clerk of the Association to keep a regular file of the printed minutes of every session of this body, and upon a change of officers the late Clerk shall deliver such file to his successor in office.

ART. 16. This Constitution may be altered or amended at any session of this body by a majority of the votes of the delegates present.

## RULES OF DECORUM.

1. The Association shall be opened and closed by prayer.
2. A Moderator and Clerk shall be elected by ballot, who shall serve one year.
3. The Moderator shall be considered a judge of order and shall have the right to call to order at any time.
4. A member not satisfied with his decision, may appeal to the Association the same day, but at no other time.
5. But one member shall speak at a time, who shall rise to his feet, and on obtaining permission proceed.
6. The Moderator, when addressed for permission to speak shall signify his assent by naming the person or otherwise.
7. No member shall be interrupted while speaking, unless he depart from the subject or use words of personal reflection.
8. Every motion made and seconded shall come under the consideration of the Association, unless withdrawn by him who made it.
9. Every case taken up by the Association shall be acted upon, or withdrawn before another shall be offered.
10. When a question is taken up, after allowing time for discussion, the Moderator shall take the voice of the Association in such mode as he may determine, and he shall announce the decision of the body immediately.
11. No member shall speak but once upon the same proposition, till every member wishing to speak shall have spoken,

and not more than twice, without leave of the Association, nor shall any proposition be made to close the discussion until the discussion shall have been carried through.

12. The appellation of brother shall be used in the Association by members in their addresses one to another.

13. The names of the members shall be called as often as the Association may direct.

14. Any member having to retire, shall obtain permission of the Moderator.

15. The Moderator shall be entitled to the same privilege in discussion as any other member, provided he appoint another to his seat during the time, but shall not vote unless the Association be equally divided.

16. It shall be the duty of the Moderator to appoint all committees for the Association.

## ARTICLES OF FAITH.

1. We believe in only one true and living God, the Maker and Supreme Ruler of Heaven and earth; and He is triune in His nature, and revealed under the personal and relative distinction of the Father, the Son and the Holy Spirit.

2. We believe the scriptures, comprising the Old and New Testaments, are the Word of God, the only rule of faith and practice.

3. We believe in the fall of Adam, and the universal corruption of human nature, and the incapacity of man to recover himself of his own free will and ability.

4. We believe in the doctrine of election, according to the foreknowledge of God the Father, through sanctification of the Spirit unto obedience; and that God chose His people in Christ, before the foundation of the world.

5. We believe that sinners are justified in the sight of God solely through the redemption and righteousness of Jesus Christ.

6. We believe that God's elect shall be called, regenerated and justified by the Holy Spirit.

7. We believe that the saints shall be preserved in grace; and kept by the power of God, and not one of them shall be finally lost.

8. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ, and that true believers are the only subject of baptism; and that immersion in water is the Apostolic and only mode.



9. We believe that no minister has any right to administer the ordinances of the Gospel, but one who is regularly baptized, called and has come under the imposition of the hands of a presbytery.

10. We believe that none but regularly baptized members have a right to commune at the Lord's table.

11. We believe in the resurrection of the dead, and in the general judgment, and that the happiness of the righteous and the punishment of the wicked will be eternal.

12. We believe that Jesus Christ authorized and organized the Baptist Christians while he was here upon this earth; and that the baptism of John, the Kingdom he preached, and the Baptists, his successors as to organization, were from Heaven; and that there has been a regular succession of Baptists until now, which have preserved pure the doctrines of the Gospel through all ages; and the gates of Hell never has, nor never shall successfully prevail against them.
